- **comprehensive system**
 - 1 800 000 documents (all languages)
 - 400 000 bibliographic notices
 - oldest documents date back to 1951
- **giving access to the Official Journal of the European Union**
- **possibility to browse through lists of documents or to search with various criteria**
- **quick, automated, loading procedures (OJ, case law)**
- **entirely free of charge**
- **managed by the Office for Official Publications of the European Communities**

- ➔ Official Journal of the European Union, L and C series (treaties, legislation, international agreements, preparatory acts, parliamentary questions, EFTA documents)
- ➔ European Court Reports (Case-law of the Court of Justice, Court of First Instance and Civil Service Tribunal)

■ Documents sent to the Office for on-line dissemination

- ➔ Communications of the Commission (proposals, reports, etc.)
- ➔ Case-law (before publication in the European Court Reports)

■ Non-official documents (for information purposes)

- ➔ Provisional versions of secondary legislation (before publication in the Special Edition of the OJ)

 - **Digest of case-law:** collection of summaries of judgments and orders of the Court of Justice, Court of First Instance and Civil Service Tribunal

- Most screens in 23 languages
- Possibility to change languages from almost every screen
- The [Official Journal](#) is published daily in 21 (23) official languages
- “Enlargement” Special editions in EUR-Lex
 - ➔ [2004](#): Czech, Estonian, Hungarian, Latvian, Lithuanian, Maltese, Polish, Slovak, Slovene)
 - ➔ [2007](#): Bulgarian, Romanian
- Documents available in as many languages as possible
 - ➔ Widest coverage for “older” languages
 - ➔ Some documents not available in all languages (ex: Case-law)
- Database allowing (soon) for searches in all languages
- Bilingual display





- **narrow legal connection**
 - **regulations in EU law belong automatically to the national system**
 - **directives of EU law impose further obligations of Member States**
 - **national judges are the first interpreters of EU law**
- **interest of authorities of Member States to know about the law of other Member States**
- **interest of authorities of Member States to disseminate knowledge about their own laws**
- **narrow economic and human connections**
- **growing academic interest**
- **growing interest of the general public**





- Experimental project opened in April 2006
- Allows searches in national legislative sites by a single uniform search template
- Multilingual thesaurus, Eurovoc, as search aid
- Developed at the request of the Council Working Group for Legal Data Protection
- 22 countries involved





■ LexAlert

- ➔ Notification system by e-mail or RSS feeds

■ Webservices

- ➔ Query, retrieve and re-use EUR-Lex data

■ PreLex

- ➔ Monitoring of the decision-making process between the institutions

■ Complete collections and extend coverage

- ➔ COM and SEC documents, Case-law, Parliamentary questions
- ➔ Documents of public interest (eg.: TARIC)
- ➔ National case-law related to Community law

■ Increase reliability, usability and user-friendliness

- ➔ Implement recommendations from usability study
